**What is this document?** This document explains what kind of study we're doing, what your rights are, and what will be done with your data. You should print this page for your records.

**Nature of the study.** You are invited to participate in a study which involves viewing images, listening to audio recordings and verbally answering questions about them. Once you finish, we may have also some questions about your experience (e.g., language background). Your responses will be audio-recorded. Your session should last for up to 15 minutes. You will be given full instructions shortly.

**Compensation.** You will be paid £2.25 for your participation in this study.

**Risks and benefits.** There are no known risks to participation in this study. Other than the payment mentioned, there are no tangible benefits to you, however you will be contributing to our knowledge about language.

**Confidentiality and use of data.** All the information we collect during the course of the research will be processed in accordance with Data Protection Law. In order to safeguard your privacy, we will never share personal information (like your name) with anyone outside the research team. Your data will be referred to by a unique participant number rather than by name. Please note that we will temporarily collect your Prolific ID to prevent repeat participation, however we will never share this information with anyone outside the research team. We will store any personal data (i.e., participant ID, audio recordings) using the University of Edinburgh's secure encrypted storage service. The anonymised data collected during this study will be used for research purposes. With your permission, identifiable data such as audio recordings (anonymous but potentially identifiable) may also be used for research or teaching purposes, and may be shared with other researchers or with the general public (e.g., we may make it available through the world wide web).

**What are my data protection rights?** The University of Edinburgh is a Data Controller for the information you provide. You have the right to access information held about you. Your right of access can be exercised in accordance with Data Protection Law. You also have other rights including rights of correction, erasure and objection. If you wish to withdraw after the specified date, we may not be able to delete your anonymised data from e.g. public repositories of research data, but we will be able to delete all of your personal data from our records.
